This is also to prevent infringement of the owner's copyright as protected by the copyright laws of the United States.

**PROCEDURE:** Prior to purchasing any entertainment promotional CD/DVD compilation for your business, you must return this signed form to Rotations with either any one of the following standard business credentials:

- A copy of your business card or:
- A page that has your published company advertisement or:
- A copy of your business registration license or:
- A tax ID form

Rotations and or our entertainment promotional product product vendors reserves the right to limit or refuse the sale of any of their CD/DVD product. Verification of your eligibility may be verified in conjunction with the sales audits submitted by Rotations to any requesting vendor, licensing or government agency.

**TO WHOM IT MAY CONCERN:** I wish to become a purchaser of entertainment only promotional CD/DVD compilation discs for my professional entertainment business, club or public access venue. I understand that I may use these discs only in connection with my professional entertainment activities, or at my club or public access venue. I agree by my signature that these discs may not be resold or exchanged for any purpose whatsoever. I acknowledge that selling or trading the entertainment promotional CD/DVD compilation discs to retailers or any other individual may constitute a violation of federal and state law, and infringement of the record master owner's copyright and may subject me to civil and criminal penalties. I find these terms and conditions satisfactory by my signature and I understand and agree to all of them.
